- (i) These programme regulations should be read in conjunction with the University's Taught Programme Regulations.
- (ii) All optional modules are offered subject to the constraints of the timetable and to any restrictions on the number of students who may be taught on a particular module. Not all modules may be offered in all years and they are listed subject to availability.
- (iii) Unless otherwise stated under 'Type', modules are not core.
- (iv) A compulsory module is a module which a student is required to study.
- (v) A core module is a module which a student must pass.*
- (vi) All modules are delivered in Linear mode unless stated otherwise as Block, eLearning or distance learning.

1. Programme structure

- (a) The programmes (apart from the Postgraduate Certificate which is only available in part-time mode) are available for study in both full-time and part-time modes.
- (b) For the Masters, the period for full-time mode shall be one year, and part-time mode shall be two or three years starting in September.

For the Postgraduate Diploma, the period for full-time mode shall be 9 months, or part-time mode 21 months starting in September.

For the Postgraduate Certificate, the period for part-time mode shall be 9 months starting in September.

- (r) Optional modules must be approved by the Degree Programme Director and must not exceed the University regulations in relation to credit splits across semesters i.e. no more than 70 credits per semester.
- (s) All taught modules are available for study as standalone CPD under the Credit Accumulation and Transfer Scheme (CATS) Regulations but will not contribute to an award.

2. Assessment Methods

Details of the assessment pattern for each module are explained in the module outline.

3. Progression and Assessment

- (a) The Masters degree, the Postgraduate Diploma and the Postgraduate Certificate are awarded as follows:
 - a. 50 59 Pass
 - b. 60 69 Pass with Merit
 - c. 70 or above Pass with Distinction.
 - i. For the award of Masters with Distinction candidates must also have passed all modules on the first occasion without the need for resits, and have achieved an overall mark of 70 or greater in the Dissertation component of the degree programme.
 - ii. For the award of Postgraduate Diploma/Postgraduate Certificate with Distinction candidates must also have passed all modules on the first occasion without the need for resits.
 - iii. For the award of Masters with Merit candidates must also have either passed all modules on the first occasion without a need for resits, or have no more than 20 credits of modules passed by resits, and have achieved an overall mark of 60 or greater in the Dissertation component of the degree programme.
 - iv. For the award of Postgraduate Diploma/Postgraduate Certificate with Merit candidates must also have either passed all modules on the first occasion without a need for resits, or have no more than 20 credits of modules passed by resits.
- (b) Candidates studying the Masters may exit with a Postgraduate Certificate as a lesser award if 60 taught credits have been passed or a Postgraduate Diploma if 120 taught credits have been passed. Candidates studying the Postgraduate Diploma may exit with a Postgraduate Certificate as a lesser award if 60 taught credits have been passed. The title of the award will be dependent on the modules passed and the requirements of the programme regulations. These may be awarded as follows:
 - a. 50 -59 Pass
 - b. 60 -69 Pass with Merit
 - c. 70 or above Pass with Distinction.
- 4. Exemptions to the University's Taught Programme Regulations

Section G – Section 98 & 102 The Award of Postgraduate Certificate and Diploma (Exit Awards)

The Public Health suite of programmes has an exemption from the University's Taught Programme Regulations in relation to the criteria for determining awards with Merit and Distinction (entry awards), approved by the Faculty Education Committee – see Section 3. (a).

The Public Health suite of programmes has an exemption from the University's Taught Programme Regulations which allows exit awards with Merit or Distinction - see section 3. (b).
