- (ii) All optional modules are offered subject to the constraints of the timetable and to any restrictions on the number of students who may be taught on a particular module. Not all modules may be offered in all years and they are listed subject to availability.
- (iii) Unless otherwise stated under 'Type', modules are not core.
- (iv) A compulsory module is a module which a student is required to study.
- (v) A core module is a module which a student must pass, and in which a fail mark may neither be carried nor compensated; such modules are designated by the board of studies as essential for progression to a further stage of the programme or for study in a further module.
- (vi) All modules are delivered in Linear mode unless stated otherwise as Block, eLearning or distance learning.

3. Placement Year

- (c) If a pass mark is obtained for the Professional Placement, in addition to a student meeting the criteria for the BSc in Psychology, then the degree of BSc Psychology with Professional Placement will be awarded. Failure to pass the Professional Placement will result in the candidate being transferred to the BSc (Hons) Psychology award.
- (d) In order to pass PSY3000 candidates must achieve a pass in each of three components of assessment; a poster, a reflective log, and supervisor reports. If the poster or reflective log is failed, it will have to be retaken and a pass mark obtained. However, no resit can be offered for the supervisor reports. Thus if the supervisor reports are failed, this will constitute a fail for the entire module.

5. Inverted International Study Year – Code 1731U

- a) On completion of Stage 3 and before completion of their studies candidates may spend the equivalent of one academic year abroad at an appropriate exchange partner institution. Permission to undertake a year abroad is subject to the approval of the Degree Programme Director. Students who are required to re-sit their Stage 3 assessment must delay the start of their year abroad until they have done so. Students who fail Stage 3 may not complete a year abroad. Note: This is only available to students completing the Inverted Placement during 2021/22.

6. Assessment methods

Details of the assessment pattern for each module are explained in the module outline.

7. Degree classification

Candidates will be assessed for degree classification on the basis of all the modules taken at Stages 2 and 3; the weighting of the stages being 1:2. The Professional and Careers Placement years, as well as the International Year Abroad, do not formally contribute to the degree classification. However, candidates on these awards must pass their placement year/study abroad year to graduate with the degree title BSc Hons Psychology with Professional Placement or BSc Hons Psychology with Placement Year or BSc Hons Psychology with Study Abroad

8. Exemptions to the University's Taught Programme Regulations

The BSc Honours Psychology with Professional Placement has a University exemption from the University's Taught Programme Regulations in relation to the offer of a resit opportunity for the Supervisor Report, which forms part of the assessment regime of PSY3000 – see Section 3(d). In the event of any inconsistency between the programme and University regulations in relation to the above section, the programme regulations take precedence over the University regulations.
