1. Programme structure

- a) Candidates are normally expected to pass the taught modules before proceeding to the dissertation.
- b) The Programme has been granted an exemption from the normal regulations, so that a student who fails up to 20 credits of non-core modules of the programme is recommended, as of right, for the award of an appropriate Master's degree or Postgraduate Diploma, provided that no single mark for any module assessed is below 40 and the weighted average mark for all modules (taking credit values into account) is at least 50. Such a student will be eligible as of right only for the award of a pass classification.
