- (v) *A core module is a module which a student must pass, and in which a fail mark may neither be carried nor compensated; such modules are designated by the board of studies as essential for progression to a further stage of the programme or for study in a further module.*
- (vi) *All modules are delivered in Linear mode unless stated otherwise as Block, eLearning or distance learning.*

3. Year 3 (Intercalating Year)

- a. On completion of Stage 2 and before entering Stage 3, candidates on the L161 BSc (Hons) in Economics and Finance programme who wish to undertake a placement with an approved organisation will transfer to L166 BSc (Hons) in Economics and Finance (with Placement).
- b. For academic year 2021/22 only, the intercalating year studying abroad can be undertaken following completion of Stage 3 for candidates completing Stage 2 in 2019/20. For all other candidates the intercalating year studying abroad shall be taken upon completion of Stage 2 and before entering Stage 3.
- c. Permission to undertake a placement or study abroad is subject to the approval of the Degree Programme Director. It is the responsibility of individual students to make sure they meet the visa requirements of the country in which they plan to undertake a study/work placement- Travel and study abroad will be guided by institutional and government guidance at the time.
- d. The University **will** withdraw UK student (Tier 4) visas for International students spending a year overseas. It will then be the sole responsibility of the student to re-apply, in a timely fashion, for a UK student (Tier 4) visa to return to Newcastle to complete their studies.
- e. During their intercalating year, students are required to take the following module:

6. Assessment methods

Details of the assessment pattern for each module are explained in the module outline.

7. Degree classification

Candidates will be assessed for degree classification on the basis of all the modules taken at Stages 2 and 3 with the weighting of 0:1:2 for the three stages.

L166 placement year, L167 study abroad year and 1445U placement and study abroad are assessed on a pass/fail basis and do not contribute to the degree classification.

8. Name of Award

Candidates who choose to take the intercalating year shall be transferred onto one of the four stage versions of the programme depending on where it is taken:

- Candidates who study abroad will be transferred onto the L167 programme and will graduate with a BSc (Hons) Economic and Finance (with Study Abroad).
- Candidates who were intending to intercalate in 20/21 and are instead intercalating in 21/22, will be transferred onto 1711U and will graduate with a BA (Hons) in Economics and Finance (with Year Abroad).
- Candidates who choose to take a work placement will be transferred onto the L166 programme and will graduate with a BSc (Hons) Economics and Finance (with Placement).
- Candidates who choose to do both a work placement and a study abroad scheme will be transferred onto the 1445U programme and will graduate with a BSc (Hons) Economics and Finance (with Work Placement and Study Abroad).
