- (ii) All optional modules are offered subject to the constraints of the timetable and to any restrictions on the number of students who may be taught on a particular module. Not all modules may be offered in all years and they are listed subject to availability.
- (iii) Unless otherwise stated under 'Type', modules are not core.
- (iv) A compulsory module is a module which a student is required to study.
- (v) A core module is a module which a student must pass, and in which a fail mark may neither be carried nor compensated; such modules are designated by the board of studies as essential for progression to a further stage of the programme or for study in a further module.
- (vi) All modules are delivered in Linear mode unless stated otherwise as Block, eLearning or distance learning.

1. Year 3 Year Abroad in Europe (Intercalating Year)

As an integral part of their studies, candidates are normally required to spend a complete academic year, between the end of Stage 2 and the beginning of Stage 3, pursuing courses of study (equivalent to 120 credits) approved by the Degree Programme Director at universities or other comparable institutions in a European Union country or countries where the majority language is not English. A Politics related work placement in a European Union country or countries where the majority language is not English may be substituted with the approval of the Degree Programme Director. Students may opt to take POL3043 (GEUS Year Abroad, 20 credits) in which case the Board of Examiners shall substitute their marks for POL3043 for up to 20 credits of their marks at Stage 2 if that is to their advantage.

Travel and study abroad will be guided by institutional policy and governmental guidance at the time. Placement opportunities will be guided by national and institutional policy at the time.

2. Stage 3

- (a) All candidates shall select modules to a total value of 120 credits, the choice to be made with the approval of the Degree Programme Director.
- (b) All candidates shall take at least 20 and not more than 60 credits of optional modules from the following list:
