#### Notes

- (i) *These programme regulations should be read in conjunction with the University's Taught Programme Regulations.*
- (ii) *A core module is a module which a student must pass.*
- (iii) *A compulsory module is a module which a student is required to study.*
- (iv) *In the programme individual taught modules are optional; however all students undertake a dissertation or research project. Modules should be selected to balance workload across semesters.*
- (v) *All students register for the MEd Practitioner Enquiry, but may, subject to module choices and dissertation topic, opt to transfer to the MEd Practitioner Enquiry (Leadership) and graduate with that award. Transfers will be made at the point at which dissertation proposals are agreed.*

#### 1. Programme structure

- (a) The programme is available for part-time study only. It is specifically designed to be undertaken by students who work in an educational context.
- (b) The period of study for part-time mode shall normally be 3 years starting in September or January.
- (c) The programme comprises taught modules to a credit value of 120 plus a 60 credit dissertation or action research portfolio.
- (d) Candidates who have taken a Newcastle PGCE at level 7 may transfer the 60 credits direct to the MEd and their PGCE marks will be used in assessing the result of the MEd (see modules below). Normally, not more than 5 years may elapse for candidates to transfer PGCE credits, although this may be extended through submission of evidence of how the resulting learning has continued to be applied and developed in professional contexts.
- (e) Modules EDU8900, EDU8901, EDU8902, EDU8904, EDU8905, EDU8906, EDU8110, EDU8139, EDU8111 and EDU8143 can be used towards the PG Certificate in Educational Leadership. Alternatively, students already registered for a Postgraduate Certificate in Educational Leadership, MEd Practitioner Enquiry or MEd Practitioner Enquiry Leadership can apply for these modules.

- (f) Candidates may use Credit Transfer or Recognition of Prior Learning (RPL) for up to 60 level 7 credits taken at other Universities in the Postgraduate Professional Development North East (PPDNE) Consortium with the approval of the Degree Programme Director, but without the need for approval from the Dean of Postgraduate Studies.
- (g) Candidates may transfer 60 credits from a level 7 PGCE taken at another university with the approval of the Degree Programme Director, but without the need for approval from the Dean of Postgraduate Studies.
- (h) Candidates may transfer 60 credits from Newcastle University's Postgraduate Certificate in Academic Practice with the approval of the Degree Programme Director, but without the need for approval from the Dean of Postgraduate Studies.
- (i) Candidates may transfer up to 40 credits from study elsewhere subject to the approval of the Degree Programme Director and up to 60 credits with the approval of the Dean of Postgraduate Studies.

(t) Candidates entering at Year 2 of the programme with 60 credits from an approved level 7 PGCE course who would like to undertake the leadership pathway must:

- Complete EDU8095 Research Strategies and Methods (20 credits);
- Complete at least 40 credits from the optional leadership modules.

Candidates are advised that this is most suitable for teachers who have begun to take a leadership or management role in school.

(u) In accordance with the University's Postgraduate Taught Examination Conventions candidates who have taken 60 credits of leadership modules may exit with a Postgraduate Certificate in Practitioner Enquiry (Leadership). Candidates who have passed at least 100 of 120 credits from the leadership modules may exit with a Postgraduate Diploma in Practitioner Enquiry (Leadership).

(v) Candidates who have previously completed one or two Postgraduate Certificates, or a PGCE will be permitted to accumulate these credits and use towards completing their MEd Practitioner Enquiry programme or MEd in Practitioner Enquiry Leadership programme.

(w) Candidates who have successfully completed one Postgraduate Certificate are permitted to use the 60 credits and enter Year 2 of the MEd in Practitioner Enquiry programme or the MEd in Practitioner Enquiry Leadership programme.

(x) Candidates who have successfully completed two Postgraduate Certificates in ECLS are permitted to use the 120 credits and enter dissertation year of the MEd in Practitioner Enquiry programme or the MEd in Practitioner Enquiry Leadership programme.

(y) Candidates on the Leadership Pathway must complete the currently stated leadership focused modules either as part of the MEd Practitioner Enquiry Leadership programme or through the Postgraduate Certificate in Educational Leadership programme.

(z) Accumulated credits from Postgraduate Certificates or a PGCE must be used within five years from being awarded.

## **2. Exemption from the University Regulations**

In line with the University Policy on Credit Transfer and the Recognition of Prior Learning an exemption has been granted to allow students on this programme to transfer up to 120 credits from relevant postgraduate certificates already successfully completed in the School.
