- (ii) All optional modules are offered subject to the constraints of the timetable and to any restrictions on the number of students who may be taught on a particular module. Not all modules may be offered in all years and they are listed subject to availability.
- (iii) Unless otherwise stated under 'Type', modules are not core.
- (iv) A compulsory module is a module which a student is required to study.
- (v) A core module is a module which a student must pass, and in which a fail mark may neither be carried nor compensated; such modules are designated by the board of studies as essential for progression to a further stage of the programme or for study in a further module.
- (vi) All modules are delivered in Linear mode unless stated otherwise as Block, eLearning or distance learning.

(e) Candidates may take modules, totalling 20 credits, in a foreign language, but only with approval of the Degree Programme Director. Alternative arrangements are in place for students wishing to start learning a new language as beginners.

(f) In the event of a student electing to take 20 credits in a foreign language, the compulsory modules listed above (a) may not be dropped, and at least 20 credits must be taken from (c) above.

*\*Candidates may only take one of the following modules: MUS1101, MUS1102 or MUS1103, but may take this in conjunction with MUS1010.*

- (d) Candidates will select an additional 20 credits of modules, from the lists above so that they take a total of 120 credits at Stage 2. Students cannot take more than 70 credits and no less than 50 credits in a single semester.

### 3. Year Abroad

- (a) Students may with the permission of the Degree Programme Director, at the end of stage 2 and before entering stage 3, spend a year abroad with one of our partner institutions as part of the degree **or** take part in a placement with an approved organisation (see 4. Placement Year). To qualify for the year abroad, students will need to meet a threshold of at least 60% in the first three semesters of study. Students following this route will transfer to Bachelor of Arts with Honours in Folk and Traditional Music (with Year Abroad), 1344U. The Degree Programme Director will confirm the transfer in each case.

- (c) It is the responsibility of individual students to make sure they meet the visa requirements of the country in which they plan to undertake a year abroad. Travel and study abroad will be guided by institutional and governmental policy at the time.
- (d) The University **will** withdraw UK student (Tier 4) visas for International students spending a year overseas. It will then be the sole responsibility of the student to re-apply in a timely fashion, for a UK student (Tier 4) visa to return to Newcastle to complete their studies.

### 4. Placement Year

- (a) On completion of Stage 2 and before entering Stage 3, candidates may as part of their studies for the degree spend a year in a placement with an approved organisation **or** take part in a year abroad (see 3. Year Abroad). Permission to undertake a placement is subject to the approval of the Degree Programme Director. Students who are required to re-sit their Stage 2 assessment must delay the start of their placement until they have done so. Students who fail Stage 2 may not complete a placement year. Students following this route will transfer to Bachelor of Arts with Honours in Folk and Traditional Music (with Placement Year), 1672U.

(c) Candidates electing to take a Minor Specialist Study should normally take this in a different area from their Major Specialist Study. However, with the approval of the Degree

Programme Director, a Major and a Minor Specialist Study module may both be taken in performance, provided that each is devoted to a different instrument, or one to voice. Please note these performances will be separate recitals, and it is not possible to merge a Major and Minor Specialist Study Performance into one extended recital. Exceptionally, a double major in performance (MUS3064)\*\* may be permitted for students who have achieved over 75% in both instruments (or voice) at the end of Stage 2. In this case the final assessment may be performed as either two separate recitals of 40 minutes in length, or the student may decide to use both instruments or voice in a 2 x 40 minute recital format, which will be programmed consecutively and run as a standard professional length concert (with an interval between each half). All students must undertake a module that results in an extended piece of written academic work; this might be a major or minor dissertation or project but if a dissertation option is not taken the student must take a 20-credit historical/cultural option.

- (d) Note: W344 or 1344U students doing a major and minor specialist study in performance would normally not be allowed to choose MUS3093 as well, but in exceptional cases, this may be approved by the Degree Programme Director.
- (e) All candidates shall take modules from the following list such that their credits total 120. Candidates should have no more than 70 and no less than 50 credits per semester.

## **7. Degree classification**

Candidates will be assessed for degree classification on the basis of all the modules taken at Stages 2 and 3 with the modules at stage 2 counting as one third and the modules at stage 3 counting as two thirds of the final total weighting.

## **8. Degree Title**

Candidates who spend a Year Abroad shall be transferred onto the four-year version of the programme. They will be on programme code 1344U and those who pass the relevant assessments graduate with a BA (Hons) in Folk and Traditional Music (with Year Abroad).

Candidates who choose to take part in the Placement Year shall be transferred onto the four-year version of the programme. They will be on degree programme code 1672U and will graduate with a BA (Hons) in Folk and Traditional Music (with Placement Year).
