**10 Programme Aims**

- 1** To meet the aims of the ESRC's postgraduate research training guidelines by providing high quality research training at Master's level
- 2** To provide learning opportunities to enable graduates to acquire the knowledge and understanding, skills and aptitudes necessary to undertake advanced research in the social sciences generally and political science specifically
- 3** To provide high quality research training to an increasing number of postgraduates and to enhance their skills and employability
- 4** To offer a research-informed environment in which students can learn about at least one area of the discipline of Politics from knowledgeable staff, their own study and from interaction with fellow students
- 5** To develop the students' experience of, and skills in, conducting self-designed research papers and dissertations and provide an opportunity to undertake a major research project for their dissertation in Politics. To enhance students' skills in processing, analysing and presenting information
- 6** To offer a research-informed environment in which students can learn about at least one area of the discipline of Politics from knowledgeable staff, their own study and from interaction with fellow students.
- 7** To produce graduates who can proceed to careers in research in universities, in the public sector, the private sector, the voluntary sector and the media
- 8** To meet the needs of stakeholders
- 9** To provide a programme which meets the requirements of FHEQ at Masters level 7

**11 Learning Outcomes**

The programme provides opportunities for students to develop and demonstrate knowledge and understanding, qualities, skills and other attributes in the following areas. Qualitative and quantitative methodologies in the social sciences, information skills, concepts and methods in politics, theories and approaches to the study of politics, qualitative and quantitative methods in political science.

**Knowledge and Understanding**

On completing the programme students should:

- A1** have an advanced knowledge and understanding of ESRC recognised research methodologies

<p><b>A2</b> an advanced knowledge and understanding of political science methods and techniques required to carry out advanced research in politics</p> <p><b>A3</b> have a foundation of specialist knowledge and research skills from which they can embark upon careers with significant research responsibilities or pursue a postgraduate research degree in any field of politics</p> <p><b>A4</b> have the theoretical and practical skills that will enable them to successfully complete an MA dissertation</p>
<p><b>Teaching and Learning Methods</b></p> <p>The primary means of imparting knowledge and understanding is seminars in Politics and as part of the HASS Faculty Research Training Programme (A1-A4). Throughout the MA programme students are strongly encouraged to engage in independent reading for which they are given extensive support and guidance on reading materials and their appropriate use. Students are strongly supported by staff in their completion of self-designed research projects.</p>
<p><b>Assessment Strategy</b></p> <p>Research skills are tested by a variety of techniques including individual and group presentations, research exercises and papers, and ultimately, the dissertation (A1-A4).</p>
<p><b>Intellectual Skills</b></p> <p>On completing the programme students should be able to:</p> <p><b>B1</b> Effectively disseminate research findings to specialist and non-specialist communities</p> <p><b>B2</b> Effectively communicate in writing and in oral presentations</p> <p><b>B3</b> Effectively manage research including design of research proposals, planning of research projects and their timely completion</p> <p><b>B4</b> Work effectively as a team member in both subject specific and multi-disciplinary settings</p>
<p><b>Teaching and Learning Methods</b></p> <p>The primary means of imparting knowledge and understanding is seminars in Politics and as part of the HASS Faculty Research Training Programme (B2-B4). Students receive explicit training in qualitative and quantitative methods, information skills, and in reflective approaches to research problems and issues in such seminars and are engaged in individual and group projects (B1).</p>
<p><b>Assessment Strategy</b></p> <p>General research skills are assessed by means of coursework research and reflective projects and ultimately the MA dissertation (B1-B2). Other modes of assessment include the construction of a bibliography, incorporating bibliographic search strategies and professional design and layout (B3). IT skills are assessed by the bibliographic exercise and data practicals (B3). Students will also receive ethics training and complete a jointly produced 6000 word research article with the aim of it being published in an appropriate journal (B1, B4).</p>
<p><b>Practical Skills</b></p> <p>On completing the programme students should be able to:</p> <p><b>C1</b> Select and apply appropriate methods of data collection with knowledge and understanding</p> <p><b>C2</b> Understand the strengths and weaknesses of different kinds of data and develop a critical use of sources</p> <p><b>C3</b> Understand the use of methods and tools to analyse data</p> <p><b>C4</b> Demonstrate proficiency in a range of qualitative and quantitative data analysis</p>

<b>Teaching and Learning Methods</b>
Skills of data collection and management are imparted through seminars and through practical exercises in several HASS faculty FRTP modules and in the Politics module, <i>Doing Political Research</i> (C3). Critical skills are developed through independent reading and encouraging active participation individually and in groups in seminar settings (C1-C2). Reflective exercises in research design and the appropriate use of data reinforce seminar and group learning (C4).
<b>Assessment Strategy</b>
Students complete a range of assessments including research projects and the dissertation. Other assessment modes include short reflective exercises, bibliography preparation, and short answer tests (C1-C4).
<b>Transferable/Key Skills</b>
On completing the programme students should be able to: <b>D1</b> Take responsibility for his/her own learning and personal professional development <b>D2</b> Manage time and prioritise tasks by working to deadlines <b>D3</b> Communicate effectively to others when working in seminar group settings. <b>D4</b> Make effective use of appropriate electronic resources including journals, databases and the internet and undertake effective word processing
<b>Teaching and Learning Methods</b>
Student self-learning and time and task management is encouraged in weekly seminars and one on one research supervision sessions. Communication is practiced in weekly seminars. Students are directed to appropriate journals and provided information concerning appropriate internet usage.
<b>Assessment Strategy</b>
Self-learning is assessed in the context of the timely submission of research projects and completion of unseen examinations (D1-D2). Effective use of electronic resources is assessed in the context of their analysis and correct presentation in research projects and presentations (D3-D4).

<b>12 Programme Curriculum, Structure and Features</b>
<b>Basic structure of the programme</b>
One year full time or two years part time. 180 credits (110 coursework, 70 dissertation) 70 credits (compulsory) in HASS FRTP 20 credits (compulsory) in Politics modules 20 credits (optional) in Politics module 70 credits (compulsory) dissertation.
<b>Key features of the programme (including what makes the programme distinctive)</b>
ESRC recognised training programme which equips students with generic and subject-specific skills that enable students to undertake advanced research in the social sciences and in Politics in particular.
