- (v) All modules are delivered in Linear mode unless stated otherwise as Block, eLearning or distance learning.

1. Programme Structure

- (a) The programme is available for study in full-time mode only.
- (b) The period of study for full-time mode shall be one year beginning in September.
- (c) The programme comprises modules to a credit value of 180 Credits.

2. Semester of Exchange

- a. Candidates who have successfully passed all taught elements of Year 1 at the first or second attempt may take part in a semester of study abroad at one of the School's exchange partner institutions. Such candidates shall transfer to (5489) MSc Entrepreneurship, Innovation and Sustainability (with Study Abroad).
- b. Permission to undertake a period of study abroad is subject to the approval of the Degree Programme Director. It is the responsibility of the individual students to make sure they meet the visa requirements of the country in which they plan to undertake a period of study. Travel and study abroad will be guided by the institutional policy and governmental policy at the time.

- c. International students undertaking this option must be aware that the University will withdraw UK student (Tier 4) visas for the time spent overseas.
- d. During the period of study abroad, students are required to take the following module:

Candidates may only proceed to the capstone modules (NBS8625/NBS8627) where they have passed all the taught modules or failed no more than 20 credits of non-core modules.

Before proceeding to the capstone modules (NBS8625/NBS8627) in Semester 3, candidates are normally expected:

- (i) to pass the taught modules
- (ii) to have their ethics form and, where relevant, the travel and fieldwork risk assessment forms signed off by their supervisor

4. Degree title

Upon successful completion of the programme, the degree title awarded will be (5476) MSc Entrepreneurship, Innovation and Sustainability. Candidates who choose to take part in the Study Abroad shall be transferred onto the 18-month version of the programme and graduate with (5489) MSc Entrepreneurship, Innovation and Sustainability (with Study Abroad).
