3. Year 3 (Intercalating Year)

- a. On completion of Stage 2 and before entering Stage 3, candidates on LN12 BSc (Hons) Economics and Business Management who wish to take a placement with an approved organisation will transfer to 1112U BSc (Hons) Economics and Business Management (with Placement).
- b. Permission to undertake a placement or study abroad is subject to the approval of the
 - a. Degree Programme Director. It is the responsibility of individual students to make sure they
 - b. meet the visa requirements of the country in which they plan to undertake a study/work placement. Travel and study abroad will be guided by institutional and governmental guidance at the time.
- c. The University **will** withdraw UK student (Tier 4) visas for International students spending a year overseas. It will then be the sole responsibility of the student to re-apply, in a timely fashion, for a UK student (Tier 4) visa to return to Newcastle to complete their studies.

6. Assessment methods

7. Degree classification

Candidates will be assessed for degree classification on the basis of all the modules taken at Stages 2 and 3 with the weighting of 0:1:2 for the three stages.

1112U placement year, 1122U study abroad year and 1446U placement and study abroad year are assessed on a pass/fail basis and do not contribute to the degree classification.

8. Name of award

Candidates who choose to take the intercalating year shall be transferred onto one of the four stage versions of the programme depending on where it is taken:

- Candidates registered prior to academic year 2022/23 and who study abroad will be transferred onto the 1122U programme and will have a choice of whether they graduate with a BA (Hons) in Economics and Business Management (with Study Abroad) or BSc (Hons) in Economics and Business Management (with Study Abroad).
- Candidates registered prior to academic year 2022/23 and who choose to take a work placement will be transferred onto the 1112U programme and will have a choice of whether they graduate with a BA (Hons) in Economics and Business Management (with Placement) or BSc (Hons) in Economics and Business Management (with Placement).
- Candidates who choose to do both a work placement and a study abroad scheme will be transferred onto the 1446U programme. Candidates registered prior to academic year 2022/23 will have a choice of whether they graduate with a BA (Hons) in Economics and Business Management (with Work Placement and Study Abroad) or BSc (Hons) in Economics and Business Management (with Work Placement and Study Abroad).
- Candidates who are not taking the intercalating year or study abroad option and registered
 on the programme prior to academic year 2022/23 will have a choice of whether they
 graduate with a BA (Hons) in Economics and Business Management or BSc (Hons) in Economics
 and Business Management.
