- (iv) *All modules are delivered in Linear mode unless stated otherwise as Block, eLearning or distance learning.*

- (vi) *Upon completion of the programme, the MA degree title awarded will carry the name of the candidate's working languages A and B, and if applicable C; e.g. MA in Translation and Localisation (Language A: _____, Language B: _____). Language A is the candidate's language of best command (usually the mother tongue). Language B is the candidate's second language. Language C is the candidate's third language.*

1. Programme structure

- (a) **Stage 1** is available for study in full-time mode, only with Chinese and English as working languages. Stage 1 is the common first year, in which all students are initially registered on the MA in Translation and Interpreting (4040). Stage 1 comprises 120 credits.
 - (b) **Stage 2** is available for study to students who successfully completed Stage 1. Stage 2 consists in four MA pathways. The MA Translation and Interpreting (4178), the MA Translation and Localisation (4179), the MA Conference Interpreting (4180), and the MA Translation Studies (4181) are available for study to candidates with Chinese and English as working languages.

- (c) **Stage 2** is also available for study as a one-year MA programme to direct-entry candidates who satisfy the entry requirements for Stage 2. The period of study is 12 months for full-time mode, and 24 months for part-time mode (4179P only). Stage 2 comprises 180 credits.

The MA Translation and Interpreting (4178), the MA Translation and Localisation (4179), the MA Conference Interpreting (4180), and the MA Translation Studies (4181) are available for study to candidates with Chinese and English as working languages.

The MA Translation and Localisation (4179) and the MA Translation Studies (4181) are available for study to candidates with English and any of Chinese/French/German/Italian/Spanish as working languages.

4. Progression of study

- (a) Candidates should pass the Stage 1 taught modules and have the support of the Board of Examiners in order to proceed to stage 2.
- (b) The selection of Stage 2 pathways is based on the recommendations of the Board of Examiners in consideration of the candidates' performance at Stage 1, or in the case of Stage 2 direct entrants, is based on the qualifications stated in the Entry Requirements above when the candidates apply for the course.
- (c) In line with the University's Examination Conventions for Taught Master's Degrees,
- (i) Candidates who pass 120 credits of taught modules at Stage 1 and then exit the programme will be eligible for a Postgraduate Diploma in Translation and Interpreting.
- (i) Depending on their pathway, candidates who pass 120 credits of taught modules at Stage 2, but exit without successfully completing the dissertation or translating/interpreting/subtitling project will be eligible for:
- Postgraduate Diploma in Advanced Translation and Interpreting, *or*
Postgraduate Diploma in Advanced Translation and Localisation, *or*
Postgraduate Diploma in Advanced Conference Interpreting, *or*
Postgraduate Diploma in Advanced Translation Studies.

5. Degree Classification

Candidates will be assessed for degree classification on the basis of all the modules taken at Stage 2 of the programme.
