

## Programme Regulations: 2025/26

### MA Music

Code: 4190 F/P

#### Notes

- (i) *These programme regulations should be read in conjunction with the University's Taught Programme Regulations.*
- (ii) *A core module for outcomes is a module which a student must pass.*
- (iii) *A core module for PSRB accreditation is a module a student is required to obtain accreditation*
- (iv) *A compulsory module is a module which a student is required to study.*
- (v) *All modules are delivered in Linear mode unless stated otherwise as Block, eLearning or distance learning.*

#### 1. Programme Structure

- (a) There are two named strands to the MA Music: Performance and Composition.
- (b) The programme is available for study in both full-time and part-time modes.
- (c) The period of study for full-time mode shall be 1 year starting in September. The period of study for part-time mode shall normally be 2 years starting in September.
- (d) The programme comprises modules to a credit value of 180. Part-time candidates shall distribute their learning over the two-year period as shown below. Deviations from these routes will only be allowed in exceptional circumstances, and with the written approval of the Degree Programme Director. In such cases the workload should be divided as evenly as possible between the semesters of study.
- (e) All candidates on the **performance strand** shall take the following compulsory modules:
