#### Notes:

- (i) These programme regulations should be read in conjunction with the University's Taught Programme Regulations.
- (ii) All optional modules are offered subject to the constraints of the timetable and to any restrictions on the number of students who may be taught on a particular module. Not all modules may be offered in all years, and they are listed subject to availability.
- (iii) A core module for learning outcomes is a module which a student must pass.
- (iv) A core module for PSRB accreditation is a module a student is required to obtain accreditation.
- (v) A compulsory module is a module which a student is required to study.
- (vi) All modules are delivered in distance eLearning mode.

## 1. Programme structure

- (a) The programmes are available for study in part time mode and are fully web-based delivered by distance e-learning.
- (b) Candidates commence their studies in September.

For the Masters, the period of study for part-time mode shall be three to five years.

For the Postgraduate Diploma, the period of study for part-time mode shall be two to four years.

For the Postgraduate Certificate, the period of study for part-time mode shall be one to two years.

- (c) The Masters programme comprises modules to a credit value of 180. The Postgraduate Diploma programmes comprises modules to a credit value of 120. The Postgraduate Certificate programmes comprises modules to a credit value of 60.
- (d) All candidates aiming to complete the MSc in Oncology in three years or the Postgraduate Diploma in Oncology in two years shall take the following compulsory modules in the first year of study:

All candidates aiming to complete the MSc in Oncology in four to five years or the Postgraduate Diploma in Oncology in three to four years shall take the following compulsory modules by the end of the second year of study. In year two of study candidates shall take all remaining compulsory modules not studied in year one and they may select optional modules (excluding all dissertation modules) up to the maximum credit limit permitted as detailed in Section 3 b):

(k) All modules other than dissertation modules are available for study as standalone CPD under the Credit Accumulation and Transfer Scheme (CATS) Regulations. Modules passed under these regulations will not contribute to an award, however candidates who wish to go on to study for one of the awards listed above may be able to transfer their credits – see section 3.i for the criteria for transfer.

#### 2. Assessment Methods

Modules and assessment activities are detailed in the module outlines.

#### 3. Progression and Assessment

- (a) The duration of the programme that you undertake will determine the order that you take your modules in, the number of modules that you shall normally take per semester, and academic year for your chosen award (see section 1b for programme structure).
- (b) Please see the appendix of these regulations for a comprehensive breakdown of the value of credits you must study for each semester and academic year of your programme.
- (c) All awarded credits expire after five years of study unless an interruption of studies is recorded.

- (d) To pass ONC8022 Cancer Molecular Biology & Targeted Therapies (E-learning), candidates are required to achieve an overall pass mark of 50 or above for both assessments in the module as well as the module overall.
- (e) To pass ONC8025 Cancer Pathology and Molecular Applications for Screening, Diagnosis and Treatment (E-Learning), candidates are required to achieve an overall pass mark of 50 or above for both assessments in the module as well as the module overall.
- (f) To pass ONC8027 Cancer Drug Development and Innovative therapies (E-Learning), candidates are required to achieve an overall pass mark of 50 or above for both assessments in the module as well as the module overall.
- (g) The Masters degree, the Postgraduate Diploma and the Postgraduate Certificate are awarded in line with the Common Marking Scheme as follows:
  - a. 50 59 Pass
  - b. 60 69 Pass with Merit
  - c. 70 or above Pass with Distinction.
- (h) Candidates studying the Masters may exit with a Postgraduate Certificate as a lesser award if 60 taught credits have been passed or a Postgraduate Diploma if 120 taught credits have been passed. Candidates studying the Postgraduate Diploma may exit with a Postgraduate Certificate as a lesser award if 60 taught credits have been passed. The title of the award will be dependent on the modules passed and the requirements of the programme regulations. These may be awarded as follows:
  - a. 50 59 Pass
  - b. 60 69 Pass with Merit
  - c. 70 or above Pass with Distinction.
- (i) Candidates studying on a standalone basis who wish to be considered for any of the above Postgraduate Certificate awards must transfer onto the appropriate programme after passing modules to a maximum value of 20 credits, approval of the transfer will be dependent on the modules passed and the requirements of the programme regulations. Candidates studying on a standalone basis who wish to be considered for any of the above Postgraduate Diploma or Masters awards must transfer onto the appropriate programme after passing modules to a maximum value of 40 credits, approval of the transfer will be dependent on the modules passed, the validity of the modules and the requirements of the programme regulations.
- 4. Exemptions to the University's Taught Programme Regulations

## Section G The Award of Postgraduate Certificate and Diploma (Exit Awards)

The Oncology and Palliative Care suite of programmes has an exemption from the University's Taught Programme Regulations which allows exit awards with Merit or Distinction - see section 3. (h).

In the event of any inconsistency between the programme and University regulations in relation to the above section, the programme regulations take precedence over the University regulations. Further guidance is contained in the Programme Handbook available on the virtual learning environment.
