### 1. Programme Structure

# 2. Semester of Exchange

- b. Permission to undertake the semester of exchange is subject to the approval of the Degree Programme Director. It is the responsibility of the individual students to make sure they meet the visa requirements of the country in which they plan to undertake a period of study. Travel and study abroad will be guided by the institutional policy and governmental policy at the time.
- c. International students undertaking this option must be aware that the University will withdraw UK student (Tier 4) visas for the time spent overseas.

# 3. Dual Award – Outgoing students

- Candidates who have successfully passed all taught elements of Year 1 at the first or second attempt may, if selected through an application process, take part in a Dual Award at a participating NUBS partner institution, undertaking an additional year of study. Such candidates shall transfer to (5499N) MSc Sustainability Management (Dual Award).
- Permission to undertake a second year of study abroad is subject to the approval of the
  Degree Programme Director. It is the responsibility of the individual students to make sure
  they meet the visa requirements of the country in which they plan to undertake a second
  year of study. Travel and study abroad will be guided by the institutional policy and
  governmental policy at the time.
- International students undertaking this option must be aware that the University will withdraw UK student (Tier 4) visas for the time spent overseas.

### 7. Degree Title

Upon successful completion of the programme, the degree title awarded will be (5499F) MSc Sustainability Management. Candidates who choose to take part in the Study Abroad shall be transferred onto the 18-month version of the programme and graduate with (5500F) MSc Sustainability Management (with Study Abroad).

Candidates who choose to take part in the Dual Award shall be transferred onto the 24-30 month version of the program and upon successful completion of their second degree, will graduate with;
