Programme Title: MSc Public Policy

Notes

- (i) *These programme regulations should be read in conjunction with the University's Taught Programme Regulations.*
- (ii) *A core module is a module which a student must pass.*
- (iii) *A core module for PSRB accreditation is a module a student is required to obtain accreditation.*
- (iv) *A compulsory module is a module which a student is required to study.*
- (v) *All modules are delivered in Linear mode unless stated otherwise as Block, eLearning or distance learning.*

1. Programme Structure

- (a) The programme is available for study in both full-time and part-time modes.
- (b) The period of study for full-time mode shall be one year starting in September. The period of study for part-time mode shall normally be two years starting in September.
- (c) The programme comprises modules to a credit value of 180.
- (d) All candidates shall take 140 credits of compulsory modules depending on your degree programme:

- (f) With the approval of the Degree Programme Director students may take modules to a credit value of 20 from the list above and an additional 20 credits chosen from other modules offered by GPS or other schools in the Faculty of Humanities and Social Sciences and if appropriate to your degree programme.
- (g) Additional modules may be available in subsequent years and students will be invited to select from the programme offered at the start of every academic year. Please note that not all the modules are guaranteed to run each year.
- (h) The compulsory dissertation POL8099 (60), which shall not normally exceed 10,000 words, shall be on a subject inline with your degree programme, approved by the Degree Programme Director.
- (i) The part-time programme of study will be decided in consultation with the Degree Programme Director.
