1. Programme structure

- (a) The programme is available for study in full-time.
- (b) The period of study for full-time mode shall be one year starting in September.
- (c) The programme comprises modules to a credit value of 180.

2. Semester of Exchange

- a. Candidates who have successfully passed all taught elements of Year 1 at the first or second attempt may take part in a semester of study abroad at one of the School's exchange partner institutions. Such candidates shall transfer to (5533F) MSc Project Management (with Study Abroad).
- b. Permission to undertake a period of study abroad is subject to the approval of the Degree Programme Director. It is the responsibility of the individual students to make sure they meet the visa requirements of the country in which they plan to undertake a period of study. Travel and study abroad will be guided by the institutional policy and governmental policy at the time. Updated 11.09.23
- c. International students undertaking this option must be aware that the University will withdraw UK student (Tier 4) visas for the time spent overseas.
