1. Programme structure

- (a) The programme is available for study in both full-time and part-time modes. The period of study for full-time mode shall be 1 year starting in September. The period of study for parttime mode shall normally be 2 years starting in September.
- (b) The programme comprises modules to a credit value of 180.
- (c) All candidates must take the following compulsory modules:
